**Sub: Grant of composite recognition from classes I to XII (without aid)** - with effect from academic session 1986-87, in all the three streams, i.e. Science, Commerce and Arts.

Sir,

With reference to your application on the subject cited above, I am directed to convey the approval of the Director of Education, Delhi, for the recognition of the school from Ist to XII (without aid) w.e.f. academic session 1986-87 subject to the fulfilment of the following terms & conditions:-

1. That the school shall abide by the provisions of Delhi School Education Act & Rules framed thereunder as well as the instructions issued from time to time.
2. That the school shall admit students without any discrimination of caste and creed.
3. That the school will appoint qualified staff for all the classes.
4. That the school shall establish and equip all the three Science Lab. as per the norms of the department as well as CBSE. Suitable facilities for practical work shall be provided to the students.
5. That a proper library shall be established and facilities for reading-room shall also be made available and students as well as teachers. Books as per the ratio of 10 books per student, may be added and more approved standard books may be purchased accordingly.
6. That adequate sports material for indoor games as well as for out-door games shall be purchased and made available to the students immediately.
7. That the school shall strictly abide by the provisions of Sec.10(i) of Delhi School Education Act & Rules, 1973. Payment shall be made through crossed cheque to the non-teaching and teaching staff.
8. That the enrolment of each section shall not exceed the number of students calculated @ 12 sq.ft. per student for the available floor area of the class-room and the school shall provide sufficient accommodation as per the norms of the Dept. of Education, in each class. Number of sections should not exceed the number of existing class-rooms of proper size in the school and each class-room, Science Labs. and library rooms may be fitted with electrical fans, etc.

9. That the school shall not run any unrecognised classes or any other activities within the school premises and all the recognised classes shall be run at once place at the above address only. Nursery classes be removed from the premises of the school immediately.
10. That the school shall dispense with the services of unqualified and over-aged staff, if any, immediately.
11. That the service contract between the Management and the employees shall be executed immediately.
12. That the school shall strictly follow the rules 6, 7, 8 and 9 of the DSER, 1973. Facilities as required under rules 50 and 51 of the D.S.E.R., 1973, shall be complied with strictly.
13. That the arrangements for good drinking water shall be available to all the students as well as to the staff. Sanitary facilities shall also be provided to the institutions. Health Certificate may be obtained from the Local Body every year and presently the same may be submitted within one month.
14. That the Management of the school shall create a reserve fund of Rs. 15,000/- in the name of Director of Education, Delhi, and Chairman/Manager of the School, in any Nationalised Bank.
15. That the violation of any instructions/orders/conditions rules and regulations of the department shall lead to the withdrawal of recognition of the school.
16. That the report about the fulfilment of the above conditions giving the extent to which each condition is fulfilled shall be sent to Education Officer every six month and a report about the payment of arrears of DA or interim relief etc. shall be sent by the 31st January, 1987, to the E.O., if pending.
